Prince George's Community Federal Credit Union  
Drive Into Spring \$1000 Gas Card Sweepstakes  
Official Rules

NO PURCHASE, MEMBERSHIP, OR OBLIGATION IS NECESSARY TO ENTER OR WIN. SWEEPSTAKES IS OPEN TO MEMBERS OF PRINCE GEORGE'S COMMUNITY FEDERAL CREDIT UNION AND NON-MEMBERS WHO RESIDE IN THE COUNTY OF PRINCE GEORGE'S, MD. VOID WHERE PROHIBITED BY LAW.

PARTICIPATION CONSTITUTES PARTICIPANT'S FULL AND UNCONDITIONAL AGREEMENT TO AND ACCEPTANCE OF THESE "OFFICIAL RULES".

**I. ELIGIBILITY:** The *Drive Into Spring \$1000 Gas Card Sweepstakes* ("Sweepstakes" or "Promotion") is open to members of Prince George's Community Federal Credit Union and non-members who are legal residents of Prince George's County, MD, and 18 years of age or older as of April 1, 2022. Employees of Prince George's Community Federal Credit Union ("Sponsor" or "Prince George's CFCU"), their respective subsidiaries, vendors, advertising/promotion agencies, their immediate families (spouse, parents, IRS dependents, children and siblings, and their respective spouses) and/or those living in the same household of such employees, whether related or not, are not eligible to participate. Sponsor reserves the right to verify eligibility qualifications of the prize winner. Sweepstakes is subject to all applicable federal, state, local laws and regulations. Void in all other counties and States of the United States and U.S. Territories and wherever else prohibited by law.

**II. SWEEPSTAKES ENTRY PERIOD:** The Sweepstakes begins at 12:00 AM Eastern Daylight Time ("EDT") on April 1, 2022 and ends at 11:59:59 PM EDT on June 30, 2022 (the "Sweepstakes Entry Period"). The Sponsor's computer will be the official timekeeping device for this Sweepstakes.

**III. HOW TO ENTER THE SWEEPSTAKES:** An obligation such as being approved for an auto loan is not necessary to enter and will not improve the chances of winning the prize. An individual will be deemed an Entrant ("Entrant" or "you") in the Sweepstakes if eligible as per Eligibility requirements (Section I) and enters the Sweepstakes using at least one (1) of two (2) methods of entry described as follows:

- 1.) Auto Loan Application Entry Method: Prince George's CFCU members and non-member consumers are invited to complete a Prince George's CFCU's Auto Loan Application ("Auto Loan Application" or "Application") in person at one of Prince George's CFCU's bank branches, on the phone, or on Prince George's CFCU's website (<http://www.PrinceGeorgesCFCU.org/Auto>). Upon completion of the Auto Loan Application and agreeing with the terms and conditions, the Applicant ("Applicant") receives one (1) entry into the Sweepstakes drawing for each separate Auto Loan Application submitted. If an Applicant's Auto Loan Application had been completed and submitted prior to the Promotion's Start Date and the Application is approved during the Promotion Period, the Applicant is considered a viable Applicant and deemed an Entrant to receive one (1) Entry ("Entry") into the Sweepstakes drawing.
- 2.) Alternate Method of Entry (AMOE): Eligible Prince George's CFCU members and non-member consumers may enter the Sweepstakes without the Auto Loan Application obligation, may legibly handprint on a 3"x 5" or a 4"x 6" postcard or piece of paper your full name, street address, city, state, ZIP code (no PO Boxes allowed), daytime phone number, e-mail address, date of birth, and the location of the Prince George's CFCU you most often visit (applies to members only). Mail the entry in a **hand printed first class stamped #10 business envelope** to: Compliance / Prince George's CFCU's Drive Into Spring \$1000 Gas Card Sweepstakes, P.O. Box 468, Stonington, CT 06378. **The return address on the envelope must also be hand-printed with the sender's full name and address.** Rubber stamped or commercial printed return address labels will void the entry. An entry received by mailed is required to be postmarked by June 30, 2022 and received no later than July 6, 2022. A maximum of ten (10) postcard entries are allowed to be submitted, with each postcard mailed separately in a #10 size business envelope. Over-limit mail-in entries will be discarded. No photocopies, facsimiles or other mechanically reproduced entries are permitted. Each correctly submitted envelope receives one (1) Entry into the Sweepstakes drawing. All mail-in Entries received become the sole property of the Sponsor and will not be acknowledged or returned. Sponsor is not responsible for late, lost, incomplete, illegible, incorrect, damaged, postage due, or misdirected entries, all of which will be disqualified.

Proof of mailing or proof of sending (such as an automated computer receipt confirming Entry or "thanks for applying for an auto loan" message) does not constitute proof of actual receipt/delivery of an Entry for purposes of this Sweepstakes. By participating in the Sweepstakes, all Entrants agree to be bound by these Official Rules, which are final and binding on all matters pertaining to this Sweepstakes.

**IV. PRIVACY & PERSONAL INFORMATION & OPT-IN:** At the time of Sweepstakes entry, Entrants will have the opportunity to opt-in to receive further communications from the Sponsor. Entrants are not required to opt-in to participate in this Sweepstakes and opting in will not increase your chances of winning. If an Entrant chooses to opt-in, the Entrant thereby grants the Sponsor permission to send him/her future communications regarding services, incentives, offers, promotions, or other messaging related to the Sponsor's services and products. Any information collected from the Sweepstakes shall be used only in a manner consistent with the consent given by the Entrants at the time of entry, with these Official Rules, and with the Sponsor's Privacy Policy found at: <https://www.princegeorgesfcu.org/personal-finance-solutions/services/privacy>.

**V. WINNER DRAWING, NOTIFICATION AND ODDS:** One (1) potential Grand Prize Winner ("Winner") will be randomly selected on or about July 28, 2022, by a third-party administrator ("the Administrator"), an independent judging organization, whose decisions are final in all matters relating to this Sweepstakes. Potential Winner will be notified by phone and/or e-mail. If the potential Winner cannot be contacted or does not respond within two (2) calendar days of the initial notification, or does not respond with complete contact information as requested by voice message, or whose phone provider indicates that the phone number is invalid or unable to receive the communication (even if ultimately delivered thereafter), or found to be ineligible, cannot or does not comply with these Official Rules, or if his/her prize or prize notification is returned as undeliverable, such potential Winner will be disqualified and an alternate potential Winner may be selected at Sponsor's sole discretion. All methods of entry have an equal chance of winning. Odds of winning in this drawing depend upon the sufficient number of eligible Entries received by the Sweepstakes Entry Period deadline date in order to conduct the random drawing.

**VI. PRIZE ("Prize"):**

One (1) Grand Prize Winner is awarded a \$1,000 Gas Gift Card or a cash deposit into an existing, or a new Prince George's CFCU Savings Account. The Gas Gift Card is subject to terms and conditions that are printed on the Card. Incidental expenses and all other costs and expenses which are not specifically listed as part of a Prize in these Official Rules and which may be associated with the award, acceptance, receipt and use of all or any portion of the awarded Prize are solely the responsibility of the respective Winner. Total Prize Pool is \$1,000. (USD)

**VII. PRIZE TERMS AND CONDITIONS:** The Grand Prize Winner is required to comply with any and all applicable federal, state and local laws, rules and regulations. The value of the Prize that the Winner has been awarded is taxable as income, which the Winner is solely responsible for all matters relating to the Prize, including, but not limited to all applicable federal, state and local taxes that become due with respect to the Prize. The Winner will be required to sign an Affidavit of Eligibility and Liability/Publicity Release ("Prize Acceptance Release") and provide CSS with a valid taxpayer identification number or social security number before any prize will be awarded. Potential winner must execute and return the Prize Acceptance Release form, and a clear and readable photocopy of a legal document showing State of residence (a Driver's License). All such required documents must be received within five (5) business days following issuance of documents. If a potential winner fails to return requisite documents within the specified time period, or if a potential winner is ineligible or not in compliance with the Official Rules, then such person will be disqualified, and an alternate winner may be selected for the prize at issue.

The Sweepstakes Prize offered by the Sponsor are: (i) Non-transferable and non-refundable and must be accepted as awarded; (ii) The Release Entities make no warranty, guarantee or representation of any kind concerning any Prize; and disclaim any implied warranty; (iii) No substitution of Prize is offered, no transfer of Prize to a third party is permitted and any non-cash parts of the Prize are not redeemable for cash value, except as determined by Sponsor in its sole discretion, to substitute a Prize or Prize component with another item of comparable or greater value; (iv) Sponsor reserves the right to award a Prize of equal or greater value in the event that any of a published Prize becomes unavailable; (v) Any difference between the stated value of a Prize and the actual value of Prize will not be awarded; (vi) Upon forfeiture for any reason stated in these Official Rules, no compensation will be given except at the sole discretion of Sponsor; (vii) An unclaimed or undeliverable Prize will not be awarded after six (6) months of selection or the notification date; (viii) The Winner's Entry and acceptance of the Prize offered constitutes permission (except where prohibited) for the Sponsor to use the winner's name, photograph, likeness, statements, biographical information, voice and address (city and state) for any and all public relations, advertising and/or promotional purposes as determined by Sponsor, in all forms of media and by all manners (now and hereafter known), in perpetuity, without notice, consent, review or approval or further compensation.

**VIII. GENERAL CONDITIONS:** All materials submitted become the sole property of Prince George's CFCU and will not be returned. The Prize Release Affidavit is subject to verification by Prince George's CFCU. The awarding of the Prize is contingent on individual's full compliance with these Official Rules, as determined by Prince George's CFCU in its sole discretion. Sponsor reserves the right not to award the stated Prize if, in its sole discretion, it determines that it does not have a sufficient number of qualified entries. Acceptance of Prize constitutes permission of the Winner to allow Prince George's CFCU and its agencies the right to use Winner's name, city, state, prize information, biographical information, comments, voice, image, photograph, and/or likeness for purposes of advertising, trade, and/or publicity without further compensation in all media now known or hereafter discovered, in perpetuity, worldwide, and on the World Wide Web, without notice, review, or approval, unless prohibited by law. If Winner is found to have falsified any data or material, the Winner forfeits his/her prize and is disqualified, and an alternate Winner will be selected according to the original Winner selection method. In the event there is a discrepancy or inconsistency between disclosures, or other statements contained in any Sweepstakes or advertising materials and the terms and conditions of the Official Rules, the Official Rules shall prevail, govern, and control.

Multiple Entrants are not permitted to share the same email address. In the event of a dispute over the identity of the potential Winner, the Entry will be declared made by the authorized account holder of the email address submitted at the time of entry, and potential Winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such email address. The authorized account holder is deemed as the natural person assigned to an email address by an Internet access provider, service provider, or other organization responsible for assigning email addresses or the domain associated with the submitted email address. It is the sole responsibility of the Entrant to notify the Sponsor in writing if the Entrant changes his or her email address after the Sweepstakes Entry Period has ended. All entries become the property of Sponsor and will not be returned to Entrant. By participating in the Sweepstakes, all Entrants agree to indemnify, release, and hold harmless employees of Sponsor, its vendors, advertising agency, and their respective parent, subsidiaries, and all of their respective employees, directors, officers, agents, successors, and assigns, (collectively "Releasees" or "Released Parties"), from any injuries, losses, damages, claims, and actions of any kind resulting from or arising from participation in the Sweepstakes or acceptance, possession, use, non-use, or misuse of a Prize. Prince George's CFCU and its agents, as defined above as part of Releasees, shall not be responsible for printing, typographical, or other inadvertent errors in any Sweepstakes-related materials or other errors relating to or in connection with the Sweepstakes, including without limitation, errors which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of Winner; or Winner's paperwork to be processed that is lost, misdirected, delayed, undecipherable, fail to enter into the processing system, or are processed, reported, or transmitted late or incorrectly for any reason, including any equipment, systems, networks, lines, satellites, servers, computer, telephone, paper transfer, or human error or electronic, computer, or telephonic malfunction or error. Sponsor is not required to enter into correspondence with Entrants, including via e-mail. Sponsor and all other Released Parties (as defined above) have neither made nor are in any manner responsible or liable for any warranty, representation, or guarantee, express or implied, in fact or in law, with respect to any part of the Prize, including, without limitation, as to such Prize's quality or fitness for a particular purpose.

**CAUTION: ANY ATTEMPT TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL & CIVIL LAWS & SHOULD SUCH AN ATTEMPT BE MADE, PRINCE GEORGE'S CFCU, MD RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW.**

Prince George's CFCU's failure to enforce any terms of these Official Rules shall not constitute a waiver of that or any other provision. Each Entry must be manually key stroked and manually entered by the individual Entrant. Any automated and/or electronic submission of Entry (including but not limited to entries made using any script, macro, bot or Sweepstakes service) will be disqualified and transmissions from these or related email or IP addresses may be blocked. If, in Prince George's CFCU's opinion, there is any suspected or actual evidence of electronic or non-electronic tampering with any portion of the Sweepstakes, or if computer virus, bugs, unauthorized intervention, fraud, or technical difficulties or failures compromise or corrupt or affect the administration, integrity, security, fairness, or proper conduct of the Sweepstakes, Prince George's CFCU reserves the right at their sole discretion, to disqualify any individual who tampers with the entry process and void any entries submitted fraudulently, to modify or suspend the Sweepstakes, or to terminate the Sweepstakes and conduct a random drawing to award the Prize among all valid entries received as of the termination date. The Sponsor will not be responsible for acts of God, dangerous weather conditions, pandemic virus, acts of terrorism, civil disturbances, work stoppage, or any other matters beyond the Sponsor's reasonable control (each a "Force

Majeure” event) that may cause the cancellation or postponement of the Sweepstakes. In the event of any discrepancy between the privacy policy and these Official Rules, the privacy policy shall control and govern. **IX. DISPUTES:** Except where prohibited, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of the Entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the United States and the State of Maryland, without giving effect to any choice of law or conflict of law rules (whether of the State of Maryland, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Maryland.

Except where prohibited, as a condition of participating in this Sweepstakes, each Entrant agrees that any and all disputes that cannot be resolved between the Entrant and any Releasee, claims and causes of action arising out of or connected with this Sweepstakes, the Prize awarded, or the determination of the Winner must be resolved individually, without resort to any form of class action. Further, in any such dispute, under no circumstances will a participant be permitted or entitled to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorneys’ fees, other than participant’s actual out-of-pocket expenses (if any), and Entrant further waives all rights to have damages multiplied or increased.
